VOXMICRO manufactures a variety of Radio-Frequency related products, from modular designs, through to wireless accessory assemblies, including ODM/OEM RF systems. A large number of components are purchased from other manufacturers. The information provided regarding the material content is reliant to information received from VOXMICRO suppliers or materials for our products and therefore it is true and correct to the best of our knowledge.

This Declaration affirms that all VOXMICRO products (“our products”) comply to the above Directives. The maximum concentration values of main chemical substances prescribed by RoHS3 are shown in the below table:

Diisobutyl phthalate (DIBP)**	1000 ppm (0.1 weight %)
